- Photo ID for taxpayer (and spouse if married filing joint return)
- Social Security card and/or ITIN cards and birth dates for taxpayer, spouse and all dependents listed on the return (*required*)
- All income statements: W-2 and 1099, Social Security Benefits Statement and/or other sources of income (*required*)
- Identification number for child care provider and receipts
- Married filing joint return: both individuals must be present to complete the return
- 1098-T tuition statement for college and technical school students and relevant record of higher education expenses
- Interest & dividend statements from your bank/savings accounts
- Receipts for mortgage property taxes or interest
- Form 1095-A, B or C or Affordable Healthcare Statements
- Account and routing numbers of your financial institution (for direct deposit of any refund)
- Last year's tax return (if you filed)

- Identificación oficial con fotografía (contribuyente y cónyuge)
- Si declara con su cónyuge, ambos deben estar presentes para completar la declaración
- Tarjetas del Seguro Social o cartas de ITIN para todas las personas incluidas en la declaración (*requerido*)
- Todos los comprobantes de ingresos: W-2, 1099, etc. (*requerido*)
- Información del proveedor de cuidado de niños
- Formas y registro de gastos de educación superior: 1098-T
- Información de interés/dividendos recibidos de bancos y/o cuentas de ahorros (1099-INT y 1099-DIV)
- Recibos de pago de interés hipotecario y de impuestos sobre la propiedad
- Información sobre su seguro de salud: 1095-A, B o C
- Número de cuenta y ruta de su banco para depósito directo de su reembolso
- Declaración de impuestos del año pasado (si la presentó)
