### What to Bring

- Photo ID for taxpayer (and spouse if married filing joint return)
- Social Security card and/or ITIN cards and birth dates for taxpayer, spouse and all dependents listed on the return (**required**)
- All income statements: W-2 and 1099, Social Security Benefits Statement and/or other sources of income (**required**)
- Identification number for child care provider and receipts
- Married filing joint return: both individuals must be present to complete the return
- 1098-T tuition statement for college and technical school students and relevant record of higher education expenses
- Interest and dividend statements from your bank/savings accounts
- Receipts for mortgage property taxes or interest
- Form 1095-A, B or C or Affordable Healthcare Statements
- Account and routing numbers of your financial institution (for direct deposit of any refund)
- Last year's tax return (if you filed)
